Subj: National Senior Vice Commandant Report dated 6 August 2021

As the National Senior Vice Commandant, it has been my pleasure to serve the Marines of the Marine Corps League (MCL) in this position for the past two years. I am humbled to have this opportunity to serve each member. As the National Senior Vice Commandant, I have the responsibility to assist the National Commandant and during the absence or illness of the National Commandant, perform the duties of that office. It is my responsibility to preside over all Department Commandants' Council Conferences and with their assistance; initiate and implement dynamic programs that will increase the effectiveness of the MCL. The National Senior Vice Commandant is designated the MCL's "Corporate Secretary" and is directly responsible to the National Board of Trustees for that position.

These past two years has been challenging with COVID-19. The Board of Trustees continued to move forward with new and innovative ideals to ensure the business of the League ran smoothly. We started holding frequent Board of Trustees meeting via Zoom, teleconferencing, and in-person meetings. The Board of Trustees had to make some tough but necessary decisions in the cancellation of the 2020 National Convention and the 2021 Midwinter Conference. These were hard decisions, but the safety of the members was always paramount in our decision-making process. Cancelling the 2021 Midwinter was primarily based on the fact that the Commonwealth of Virginia was only allowing meetings in groups of ten (10) or less until the end of February 2021.

Finally, I wish to convey my appreciation to the leadership of our National Commandant Dennis Tobin and the Board of Trustees. We continue to step forward, make the hard decisions that support the League and ensure full compliance of the National Bylaws.
