### **Detachments:**

The Department of Massachusetts officers and staff have been working tirelessly with Detachments to ensure all detachments are within compliance.

We are actively working on recruiting in our Department to help Detachments rejuvenate our ranks; most Detachment Marines and Department Marines wear multiple hats and bear a tremendous amount of work pushed down the chain.

We have been going around and visiting Detachments to train them on the new Marine Corps League application as well as help out Detachments with TACOM triennial Certification.

## **Department:**

The Department Commandant, Senior Vice Commandant and Paymaster represented the Department of Massachusetts at the National Convention in Oklahoma.

The Department of Massachusetts will be conducting its annual Department Convention May 30<sup>th</sup> to June 2<sup>th</sup>, 2024, at the Sturbridge Host Hotel and Conference Center. Registrations can be conducted online through our Department website, as well as Detachments will receive convention packets in the mail to disseminate to the members.

The Department Commandant, Senior Vice Commandant, Junior Vice Commandant and Judge Advocate will be attending the Quad State/NE Division Conference in Nashau, NH on April 19<sup>th</sup> 2024.

The Department Commandant, and members from across the Department had a Q&A session with the SGMAJ of the Marine Corps on January 6<sup>th</sup> 2024. We were able to discuss the work the Marine Corps League does and how we can better help the Marine Corps, as well as the Marine Corps helping us in having access to recruiters and Marines separating from the Marine Corps.

# **Department Recruitment and Public Relations**

The Department of Massachusetts has a Recruitment Drive at the Worcester Railers Military Appreciation night March 30<sup>th</sup> 2024, which is a AAA Hockey team located in Central Massachusetts. Our department will be performing the color guard services for the game and will represent the Marine Corps League well in the eyes of the general public.

The Department hosted a Burger Burn for the 25<sup>th</sup> Marine Regiment this past summer, which Marines from the Department of Massachusetts purchased and cooked food, snacks and drinks for the Regiments Family day.

The Department is helping to host an Iwo Jima Day at the State House in Boston on February 20<sup>th</sup> 2024. This is a well attended event with people coming in from all across the Commonwealth.

The Department is helping out two Veterans organization one called Rucks 2 Pucks based out of Massachusetts and the other called Irreverent Warriors.

## **Rucks 2 Pucks**

Rucks 2 Pucks is a non-profit 501c3 charity where their mission is to help veterans and their families by promoting an active lifestyle through hockey. They promote the lifestyle to provide a sense of community and camaraderie, something veterans often lose once leaving the service. This is a key component in fighting veteran suicide and reducing the 22 a day.

How they do it is throughout the year they host events where veterans and their families can come together, talk hockey and just enjoy each other company. They rent ice for open skate, sponsor teams and/or players in leagues and tournaments.

How the Department of Massachusetts helps them is by donating to their organization as well as show up to their games to support them. The game we have supported them at was against the Boston Warriors which is a USA Hockey sanctioned all Veteran team. We will be supporting them at there next games which are against the Boston Bruins Alumni, a local Police Department, a local EMS Department and at the Heros Cup which will have 75 teams all consisting of local fire, EMS and Police Departments.

The Department looks at this as a "win-win" as we are helping out a fellow Veterans Group and getting access to prior service members who play hockey that we can recruit into the Marine Corps League.

We have already recruited 5 of their Marine members to the Marine Corps League. The average age of the members in the organization is 29, which helps bolster our ranks with younger Marines.

#### **Irreverent Warriors**

Irreverent Warriors is a nation wide group that brings Veterans together using humor and camaraderie to improve mental health and prevent Veteran suicide.

We will be working with them and supporting them when they have their Hikes in Worcester and one in the Boston area.

Once again the Department looks at this as a "win-win" as we are helping out a fellow Veterans Group and getting access to prior service members that we can recruit into the Marine Corps League.
