Detachments

Our County Commandants are actively pursuing our Detachments to ensure IRS Form 990 compliance as well as the Detachments’ registrations with the Connecticut Secretary of the State.

We have several Detachments that participated in the fall 2025 Toys for Tots drive very successfully. And a few continue to conduct Rose Days, especially on or close to national holidays.

Three Detachments, led by the Hardware City Detachment, provide riflemen for Military Honors under the auspices of the Connecticut Army National Guard. All rifles are in compliance with TACOM.

Several Detachments provide color guards for parades and ceremonies. Members from several Detachments pulled together an honor guard for a WWII Marine Corps veteran who was related to one of our members. The deceased was cremated in Virginia and received full military honors there. His family, however, lives in Connecticut and his nephew requested some kind of honors at the graveside. We had twelve members march in with behind two flagbearers. Tom Jackson and I unfolded the family's flag, refolded it, and presented it to the family. Instead of a rifle salute, because it's inappropriate to offer two for the deceased, the twelve of us sang a slow version of The Marines Hymn. The family was extremely moved and thankful. We all felt it was the least we could do for one of the Greatest Generation.

Department Admin Procedure Changes and By Laws Changes

In 2024, the Department of Connecticut Board of Trustees proposed changes to our Bylaws and Administrative Procedures. Specifically, our annual convention has been reduced to a one-day event, as we will be consolidating with the other five New England Departments to hold a New England Division (6-State) Conference, beginning this year. We are eagerly looking forward to participating in this new format.

Department of Maine Mid-Winter Conference Report

The Marine Corps League Department of Maine, a Department of the New England Division, covers a land area of 30,845.0 square miles and a water area of 4,534.8 square miles. It is the 39th largest state by area. Maine is nearly as large as all five New England States put together. Maine's population density is 43.1 people per square mile, making it the least densely populated state in New England. Maine is recognized as one of the most healthful, beautiful and interesting states in the nation. Maine presently reports 100,610 veterans with the Vietnam era veterans making up the largest veteran block in the state.

The Department of Maine consists of seven (7) Marine Corps League local Detachments spread across the state. The Department of Maine has a Military Order of Devil Dog's Pound, which includes two Devil Dog Packs. The Lobster Pound (from central Maine to the southern border of the state) and the Moose Pack (from central Maine to the northern border of the state). Our largest Detachment in the state, Southern Maine Detachment #1324, operates with a combined Regular and Associate membership at 67.

The Department of Maine and its seven (7) Detachments include a total strength of just over 300 members. This includes 260 plus regular members (Marines/Navy Corpsman) and 40 plus Associate members (consisting of veterans of sister services, Gold Star parents and supporting citizens).

The Department of Maine and its seven Detachments participate in various Marine Corps League programs. In 2025, we saw a very successful Toys for Tots collection. This program is going so well in some Detachments, that discussions are being held on how to support or staff the growing generosity of the Maine communities being served. The Department of Maine, and its detachments, offer several scholarship programs to graduating seniors as well as veterans heading into either a secondary school or trade training programs. The Detachments across the state either led or supported various veteran memorial services, performed final respects at MCL members funerals and performed various types of fund raising activities from raffles, breakfasts, golf outings or simply "shaking cans" at local businesses. All for the purposes for funding the various community programs across our state.

Our Detachments have participated in additional community programs including Wreaths Across America, selling, placing and removing wreaths on veteran gravesites, placing veteran urns at gravesites, placing flags on veteran gravesites each Memorial Day, participating in and leading the "Remember the Maine" parade and community event. This annual event offers remembrance regarding the explosion and sinking of the "USS Maine" on February 15, killing 268 sailors, or three-quarters of her crew. This was the first USN Battleship named for the state of Maine, and its sinking contributed to the outbreak of the Spanish-American War.

The year 2025 saw the 250th birthday of our United States Marine Corps and Detachments celebrated this monumental event in a variety of ways. Some were larger and others a bit smaller, however each celebration was performed with recognition of our unique and robust history, with an enthusiastic look forward, towards the future of our Corps. The largest birthday event in our state was held in Auburn Maine, hosted by our Central Maine Marines, Detachment #810, and reported greater than 150 Marines, guests, community members and as well as the leadership from our New England Division in attendance.

The MCL Department and Detachment meetings are well planned and coordinated, and offer inclusive discussion and direction to membership regarding its activities and community involvement, while also offering the fellowship as directed by our charter.

While the Department of Maine and its seven Detachments provide good community involvement, like many other Departments, the Department of Maine struggles with recruitment. It is a priority of the Department as well as its Detachments. The Department is looking at various opportunities to grow membership. Some things being explored are recruiting from other veteran groups, a more active presence in informal settings (i.e. Detachment breakfast's in public, in uniform to present a presence and demonstrated fellowship to join the league), a greater presence at various veteran events with a focus on recruitment, meeting with the local United States Marine Corps Recruiting personnel, as well as becoming involved with the local United States Marine Corps Reserve command in the state.

Along with recruitment, we realize we must also focus on retention. Many of our Detachments are made up of older members so Detachments offer flexibility, scheduling meeting times relative to the time of the year to increase member availability/participation. Additionally, the Detachment Commandants are encouraged to make their meetings meaningful and participative, to keep the interest of our members, both new and old. The activities planned, at both our MCL business meetings as well as Pound or Pack Growls, allow members to participate and feel valued to their Detachment, their Department, their Pound and Pack and the community they service, all while recognizing their association with our United States Marine Corps history.

In sum, the Department of Maine, consisting of its seven Detachments and its two Devil Dog Packs (One Pound) are working in the traditional Marine Corps spirit of "Gung Ho." Our Marines and Associates are working hard on recruiting new members, retaining our current members, upholding the traditions of our beloved United States Marine Corps, providing fellowship to each other and bringing that spirit into the communities within our Great State of Maine.

The DNHMCL has 6 detachments which cover the majority of NH. All work together to provide Military Honors for Marines and other veterans as needed. The DNHMCL facilitated 2 Marine Corps Birthday events. In the morning of the 10th, we raised the USMC flag over the NH State House and had the cake cutting ceremony with the Governor of New Hampshire. We estimate about 70 Marines were in attendance. That following evening we held a traditional ball with 200 Marines in attendance, and representatives of all detachments in attendance.

Commandant Dumont has been attending several of the detachment meetings to assess the status and discover the needs of each detachment. Many of the detachments are in a state of concern as participation continues to decrease. One detachment (#823 CAPT PAUL L GORMLEY JR has officially disbanded). The Demers Detachment (#1111) is down to a handful of members. To help locate new members Commandant Dumont has created an event called "Lunch with Leathernecks" and has schedule outreach events every Saturday from Jan to May. Where the members host a lunch event in the areas of the most need, to increase visibility and strengthen membership. We are also going to increase participation in events such as "Old Home Days" and other large events like state fairs. In May the department will be hosting the annual Memorial Day event at the New Hampshire Veteran Cemetery.
